2010 JUNIOR INNER CLUB PACKAGE

The Atkinson Resort & Country Club ("Country Club"), 85 Country Club Drive, Atkinson, NH, Junior Inner Club package is referred to below as "Junior Package".

The Applicant hereby applies to become a participant of a "Junior Package" during the year beginning January 1, 2010 and ending December 31, 2010.

1. Upon receipt by the Country Club of (a) the completed Contract, (b) the completed applicant's information form and (c) the annual fee for the amount of the package being chosen:
 - a. \$375.00 per individual
 - i. Eligible participants must be between the ages of 10-17 beginning January 1, 2010, and shall not turn 18 years old before December 31st 2010.
2. Upon execution by the Country Club's Head Golf Professional or the General Manager of this Agreement, the applicant shall be admitted to and become a Participant ("Participant") of a Junior Package.

Upon being accepted for participation in the Junior Package, Participants shall be entitled during the current year to the following privileges:

1. Discounted golf rates on the 18-hole course
 - See Rate Sheet
2. Priority in reserving a "Tee Time" for up to seven (7) days in advance
 - Two (2) day advantage over non-participants
3. Full Practice Facility privileges
 - First come, first serve basis
 - During hours of operation
 - From April 1st-November 1st
 - Does not include use of Willowcreek Golf Academy
4. 10% Discount off selected Willowcreek Pro Shop merchandise
5. Complimentary Atkinson Resort & Country Club pre-selected golf merchandise
6. 2010 USGA handicap service
7. Eligible to participate in Inner Club Tournaments
 - See Tournament Schedule (separate entry fees apply)
 - Junior Inner Club tournament participation (separate entry fees apply)
8. Storage of golf clubs and bags in the Cart Barn on a first come, first serve basis
 - April 1 through November 1
9. Inner Club Insider Newsletter
10. Automatic enrollment in Resort Rewards Program (see Resort Rewards brochure for details)
11. Discounted virtual golf rates in Merrill's Tavern Game Room

By applying for participation in Junior Package, Responsible Party on behalf of, and Participant acknowledges, accepts and agrees to the following terms and conditions of his/her continued participation in The Junior Package.

- A. This participation is not transferable to or useable by any other person or persons other than the Participant themselves.
- B. Each Participant and their guests accept responsibility for compliance with the below rules and policies of the Country Club.
- C. The Participant must notify The Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, The Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/her/their group than was previously booked, and without such prior notice to The Country Club, the "tee time" booking privileges under Junior Package may be suspended or revoked.
- D. Participant and Responsible Party accept responsibility for compliance with the attached rules and policies of The Country Club by the Participant and any guests, and agree that Participant shall not consume any alcoholic beverages or tobacco products anywhere on The Country Club premises.
- E. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with The Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled "tee time" The Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their "tee time."
- F. The Country Club reserves the right to terminate a Participants participation in The Junior Inner Club for breaches in golf etiquette, The Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of The Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, The Country Club will **not** refund any portion of the fee.
- G. Golf Carts will only be rented to Junior Platinum Package members who hold a valid drivers license and is familiar with the operations of a golf cart.
- H. The Country Club assumes no responsibility in the supervision of a Junior Package member while he/she is on The Country Club premises.
- I. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the member's only area of the Practice Facility
- J. Pace of Play Guidelines: Pace of Play Guidelines: 18-hole rounds of golf should be played in 4 hours and 40 minutes. If participant's group falls behind the group playing in front, you will be asked by a Ranger to pick up the pace of play and "get back in position" on the golf course. If a ranger has to speak to your group a second time, you will be asked to move into position on the golf course. Please remember that the group in front of you determines your pace, not the group behind. If you fail to play your 18 hole round in the allotted time, the following penalties will apply:
 - 1st offense: Written letter from Golf Committee
 - 2nd offense: Name posted on wall near handicap computer
 - 3rd offense: Tee times booked for following two weeks are booked only through Head Golf Professional Peter Doherty. You will also be eliminated from any Inner Club tournament participation for that time frame.
