

## **ATKINSON RESORT & COUNTRY CLUB**

### **2010 JUNIOR PAR 3 INNER CLUB PACKAGE**

The Atkinson Resort & Country Club ("Country Club"), 85 Country Club Drive, Atkinson, NH, Junior Par 3 Inner Club package is referred to below as "Junior Par 3 Package".

The Applicant hereby applies to become a participant of a "Junior Par 3 Package" during the year beginning January 1, 2010 and ending December 31, 2010.

1. Upon receipt by the Country Club of (a) the completed Contract, (b) the completed applicant's information form and (c) the annual fee for the amount of the package being chosen:
  - a. \$395.00 per individual
    - i. Eligible participants must be between the ages of 10-17 beginning January 1, 2010, and shall not turn 18 years old before December 31<sup>st</sup>, 2010.
    - ii. Previous playing experience is required to be considered for Junior Par 3 Package. The assessment by the Head Golf Professional of the skill level of the applicant in determining eligibility for the Junior Par 3 Package is final.
2. Upon execution by the Country Club's Head Golf Professional or the General Manager of this Agreement, the applicant shall be admitted to and become a Participant ("Participant") of a Junior Par 3 Package.

Upon being accepted for participation in the Junior Par 3 Package, Participants shall be entitled during the current year to the following privileges:

1. Unlimited greens fees on the 9-hole Par 3 course
  - Monday through Thursday anytime
  - Fridays, Saturdays, Sundays and holidays after 12:00pm
2. Priority in reserving a "Tee Time" for up to ten (10) days in advance
  - Five (5) day advantage over non-participants
3. Full Practice Facility privileges
  - First come, first serve basis
  - During hours of operation
  - From April 1<sup>st</sup>- November 1<sup>st</sup>
  - Excludes use of Willowcreek Golf Academy
4. 10% Discount off selected Willowcreek Pro Shop merchandise
5. Complimentary Atkinson Resort & Country Club pre-selected golf merchandise
6. 2010 USGA handicap service.
7. Inner Club Insider Newsletter
8. Automatic enrollment in Resort Rewards Program (see Resort Rewards brochure for details)
  - Offering rebates towards future purchases

By applying for participation in Junior Par 3 Package, Responsible Party on behalf of, and Participant acknowledges, accepts and agrees to the following terms and conditions of his/her continued participation in Junior Par 3 Package.

- A. This participation is not transferable to or useable by any other person or persons other than the Participant themselves.
- B. Each Participant and their guests accept responsibility for compliance with the below rules and policies of the Country Club.
- C. The Participant must notify The Country Club by telephone prior to the start of any tee time that the number in such Participant's party is not the number reserved for; failing which, The Country Club reserves the right to add waiting singles to the Participant's group. If a Participant shows up more than twice with fewer players in his/her/their group than was previously booked, and without such prior notice to The Country Club, the "tee time" booking privileges under Junior Par 3 Package may be suspended or revoked.
- D. Participant and Responsible Party accept responsibility for compliance with the attached rules and policies of The Country Club by the Participant and any guests, and agree that Participant shall not consume any alcoholic beverages or tobacco products anywhere on The Country Club premises.
- E. In the event Participant or any of his/her/their guests that form the group for which a reservation has been made is not checked in with The Willowcreek Pro Shop at least fifteen (15) minutes prior to the scheduled "tee time" The Country Club reserves the right to allow waiting groups to precede the Participant and cause the Participant and his/her/their group to forfeit their "tee time."
- F. The Country Club reserves the right to terminate a Participants participation in The Junior Inner Club for breaches in golf etiquette, The Country Club's rules and policies, careless play or operation of golf carts or interference or harassment of The Country Club employees or other guests by any Participant or his/her/their guests. In the event participation is terminated, voluntarily or involuntarily, The Country Club will **not** refund any portion of the fee.
- G. Golf Carts will only be rented to Junior Platinum Package members who hold a valid drivers license and is familiar with the operations of a golf cart.
- H. The Country Club assumes no responsibility in the supervision of a Junior Par 3 Package member while he/she is on The Country Club premises.
- E. Participants must present current membership card at the time of service and check in at the Willowcreek Pro Shop for services to receive your receipt for the starter. Participants must present current membership card or current bag tag to the range attendant for admittance to the member's only area of the Practice Facility.
- F. Pace of Play Guidelines: Pace of Play Guidelines: We expect each group to take no more than 10 minutes per hole, your entire 9 hole round should be a total of 90 minutes or less.
